CIRCULAR

Sub: Training to the members of Society through appropriate Licensed professionals for ensuring life safety measures of structural, Electrical, Lift, Electromechanical System & fire.

in order to provide safe and healthy habitat to eligible slum Dwellers, careful consideration needs to be paid to the Rehab Building/Rehab Wing/Composite Building / Building construction activity.

Structural Safety measures, Fire Preventive & life safety measures are important issue to avoid untoward incidence in postconstruction stage, particularly of Rehab Building / Rehab wings / Composite Buildings / Building wherein Eligible Shun Divellers are to be Rehabilitated. There is need to impart training the members of Society through appropriate Licensed professionals to ensure fire & structural safety measures of the building.

In view of above, henceforth, the Engineering Staff is directed to incorporate the following condition in the Part & Full O.C. letter to be issued to the Developer.

'Developer shall impart training to the members of Society through appropriate Licensed professionals for ensuring fire and structural safety measures of the building, maintaining continuous accessibility of the common passages, refuge areas & fire sufety areas, bringing awareness in the Society members from desisting to store inflammable materials, chemicals'

The above direction will come into force with immediate effect from date of issue of this circular.
