Sub: Request for initiating immediate actions and ensuring immediate precautions to be taken for general Upkeeping, Maintenance & general/ structural repairs to already occupied Transit Camps, accommodations of labourers & in respect of remaining ongoing construction works on Sites during monsoon period to avoid spread of any viral disease including CORONA (COVID 19) & ensure it's stoppage in Greater Mumbai and to avoid collapse & structural damages etc thereby ensure structural stability.

Gentleman / Madam,

Vide above referred letter at Sr No.1, the following instruction were already issued by this Office,

1. The SR Scheme cited is taken up by you for implementation & the implementation of the same has begun, certain construction activities are in progress accordingly.
2. You are aware that instructions in general are given to you every year prior to onset of monsoon & compliance is ensured timely to avoid any untoward incident.
3. You are further aware that monsoon is already set & Govt. is endeavoring to contain / stop the epidemic (COVID 19) simultaneously.
4. It is therefore essential that your contribution & extra ordinary efforts are essential for ensuring all such measures ensuring complete hygiene & safety of all slum dwellers/ labourers staying either in their respective accommodations or in transit camps, certain huts may be susceptible to the danger of land slides during monsoon, you shall therefore ensure that the compliance of all such general instruction given every year is timely made.

5. Besides, extra ordinary efforts should also be ensured by you for the containment / stoppage of epidemic COVID 19 so far so construction activities at subject mentioned SRS are concerned.
6. As well as, structural stability of the structures occupied by slum dwellers/ labourers such as Transit Camps or any such accommodations is ensured, moreover, probable risk to the safety of slums / accommodations of labourers such as landslides at the site cited above, is stopped by certain remedial measures in advance.
7. The instructions in general given every year, are not repeated here therefore.
8. By direction, in view of the various incidents including landslide occurred on 18/07/2021 at Bharat Nagar, Vashi Naka, Chembur & Vikroli. You are hereby once again instructed to submit structural & general audit report ensuring compliance of all the above instructions within 3 (three) days form the receipt of this letter, the structural audit report should be peer reviewed by Competent Licensed Structural Engineer, the work of remedial measures should be carried out under the supervision of your appointed Licensed Structural Engineer.
