1. That all the condition mentioned in LOI u/no. SRA/ENG/2802/KW/MHADA/LOI Dtd. 12/11/2020, 14/02/2023, 28/04/2023 & 23/11/2023 shall be complied with.

2. The built up area for sale and rehabilitation shall be as per the following scheme parameters. In the event of change in area of plot, nos. of eligible huts etc. the parameters shall be got revised from time to time.

That you shall pay premium towards an unearned income equal to 40% of difference of sale value of interchanged BUA of sale component as per ASR will be recovered in two stages 50% at the time of IOA and 50% at the time of issuing CC for the incentive FSI as per relevant Clause-G of Reg. 33(11) of DCPR-2034.
- 4. That the clubbing of PTC tenements will be constructed and handed over to the SRA/SSPL/ or competent authority.
- 5. That you shall comply all condition of SRA Circular no. 209 dtd. 01/08/2023, submit the register undertaking to that effect and display a board at site clearly indicating PAP/PTC tenants in the subjected S.R. Scheme in Marathi.

If applicant Society/Developer/Architect/L.S. are agreeable to all these conditions, then they may submit proposal for approval of plans separately for each building, in conformity with the DCPR-2034 in the office of the undersigned within 90 days from receipt of this LOI.
